The Participant hereby freely, voluntarily, and without duress executes this Release under the following terms:

1. **Release and Waiver.** Participant does hereby release and forever discharge and hold harmless **Veteran's Outdoor World, Inc.** and its designees, successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity that arise or may hereafter arise from Volunteer's Activities with **Veteran's Outdoor World, Inc.**

PARTICIPANT UNDERSTANDS THAT THIS RELEASE DISCHARGES VETERAN'S OUTDOOR WORLD, INC. FROM ANY LIABILITY OR CLAIM THAT THE VOLUNTEER MAY HAVE AGAINST VETERAN'S OUTDOOR WORLD, INC. WITH RESPECT TO ANY BODILY INJURY, PERSONAL INJURY, ILLNESS, DEATH, OR PROPERTY DAMAGE THAT MAY RESULT FROM VOLUNTEER'S ACTIVITIES WITH VETERAN'S OUTDOOR WORLD, INC., WHETHER CAUSED BY THE NEGLIGENCE OF VETERAN'S OUTDOOR WORLD, INC. OR ITS OFFICERS, DIRECTORS, EMPLOYEES, OR AGENTS OR OTHERWISE. VOLUNTEERS ALSO UNDERSTAND THAT VETERAN'S OUTDOOR WORLD, INC.
